2011 Insemination Package (On Farm or Shipped)

Package Includes:

- Unlimited checks for cycle progress
- Synchronization with stallion service farm/agent (shipped semen)
- Semen Evaluation
- Insemination
- Check for ovulation
- One - 14 – 18 day pregnancy check
- \$200/cycle/mare

Package Does Not Include:

- Return shipping charges of semen container (if applicable)
- Uterine culture & sensitivity (if applicable)
- Breeding hormones (Estrumate, Regumate, Ovuplant, etc.)
- Third party services [if applicable (veterinary, farrier, etc.)]
- Transportation fee (if applicable) of \$0.50/mile, \$25 minimum
- Daily board @ \$12/day/dry mare or \$14/day/wet mare – if applicable

Mare Owner/Agent Responsibilities (no exceptions):

- Package fee must be paid in full prior to or at time of delivery of mare to B&W.
- Copy of mare's registration papers showing current owner or lessee must be presented at time of delivery of mare to B&W.
- Copy of shipping party's contract (if applicable) including shipping terms, collection times and dates, along with shipping party's preferred contact number must be presented at time of mare's delivery to B&W.
- Mare owner/agent warrants mare to be halter broke and free of all illness and disease upon mare's arrival at B&W and warrants mare to be current on vaccinations for Strangles, Equine Influenza, Rhinopneumonitis, Tetanus, and Sleeping Sickness.

- This contract and its terms must be completed **in full**, signed, and submitted prior to or at time of mare's delivery to B&W.
- Important for shipped semen: Please make certain all applicable fees due the stallion owner/agent are paid as required or a valid credit card is on file to avoid delay in shipments.

Transferability:

This contract is non-transferable to any other party or mare other than named on this document.

Terms of service & limits of liability:

B&W, its owners or agents, in no way infers or implies that it represents, replaces, or performs licensed veterinary procedures. Mare owner/Agent agrees and understands that there is neither a present nor a resident licensed veterinarian on B&W's premises or performing procedures unless otherwise employed by mare owner/agent. All liability on the part of B&W, its owners or agents and insurance providers, ceases above and beyond the fee charged for the packaged services regardless of mare owner/agents claims. Every effort will be made to achieve conception, but no guarantees are inferred by B&W, its owners or agents. Mare owner/agent shall assume the risk and expense associated with lost or delayed shipments and shall hold B&W harmless.

All accounts unpaid beyond 14 days of statement date will be assessed a \$100 late fee per month and will accrue interest at a rate of 2% of the balance per month until balance is paid in full. No mare will be released until all charges are paid in full. No Exceptions!
